Following a brief discussion, Alderman Turner moved that the proposal be accepted understanding that the price will be \$114,253.00 and that Andrew Dulaney and Kate Scott Pennock be authorized to sign a check to pay the premium if the same is requested before the Board's regular November 2023 meeting.
